1. Cut-off Date

Notices dated July 11, 2023 convening the meeting were issued to the Secured Creditors whose names were appearing in the list of Secured Creditors of the Company as on Friday, June 30, 2023 and their voting rights were in proportion to the amount of the outstanding value of debt as on Friday, June 30, 2023, being the cut-off date for the purpose of deciding the entitlements of Secured Creditors to vote at the Meeting.

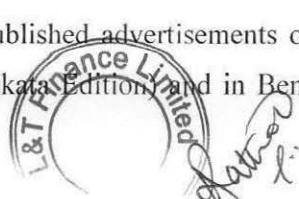
2. Notice & Advertisement

2.1. The Notice dated July 11, 2023 convening the meeting, together with a copy of the Scheme, a copy of the statement disclosing all material facts as required under Section 230(3) of the Companies Act, 2013 read with Rule 6 of the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016 was sent by July 14, 2023 to the Secured Creditors as on the cut-off date, as provided below:

- a. By email to 41,206 Secured Creditors of the Company.
- b. Out of the 41,206 emails sent by Central Depository Services Limited ("CDSL") to the Secured Creditors of Applicant Company, 1,261 emails bounced back as indicated by CDSL. The said 1,261 bounced back emails pertain to 1,056 Secured Creditors, some of whom hold debentures in various ISINs in the records of the Company, due to which multiple emails were sent to the same Secured Creditor. The notice was therefore once again sent to the said 1,056 Secured Creditors of the Company by Speed Post, i.e., 1,055 despatches by Speed Post within India and 1 despatch by Registered Airmail Post outside India both by Indian Postal Service.

3. Attendance

The meeting was attended either in person or by proxy or by authorised representatives by 16 Secured Creditors of the Company having their total outstanding liabilities amounting to INR 129,14,83,05,110.10 as on Friday, June 30, 2023.

Out of the above, 12 Secured Creditors having their total outstanding liabilities amounting to INR 129,14,36,90,110.10 had cast their vote through remote e-voting facility.

4. Remote E-Voting Process

4.1. Agency

The Company appointed Central Depository Services Limited (“CDSL”) as the agency for providing the remote e-voting platform.

4.2. Remote E-Voting Period

Remote e-voting platform was open from 09:30 A.M. (IST) on Thursday, August 10, 2023 till 05:00 p.m. (IST) on Wednesday, August 16, 2023 and Secured Creditors were given facility to cast their votes electronically conveying their assent or dissent in respect of the resolutions on the remote e-voting platform provided by CDSL.

4.3. In line with the regulatory requirements, for the purpose of ensuring that Secured Creditors who have cast their votes through remote e-voting do not vote again at the Meeting, we were provided access to only the demographic details relating to Secured Creditors, but not the manner in which they have voted after closure of period of remote e-voting and before the commencement of the Meeting.

4.4. Accordingly, after the closure of the remote e-voting process at 05:00 P.M. (IST) on August 16, 2023 and post conclusion of the meeting we downloaded the file containing demographic details of the Secured Creditors who had cast their votes through remote e-voting and shared the file with the Company.

6. Counting Process

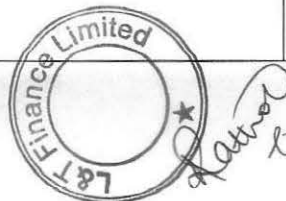

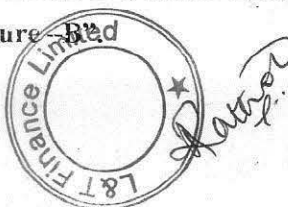
2. Notice & Advertisement

4.1. Agency

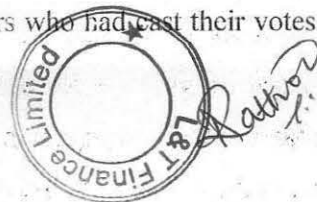
The Company appointed **Central Depository Services Limited ("CDSL")** as the agency for providing the remote e-voting platform.

5.2. After the announcement was made by the Chairperson appointed by Hon'ble NCLT for the Meeting, the Unsecured Creditors and proxies present at the Meeting voted.

6. Counting Process

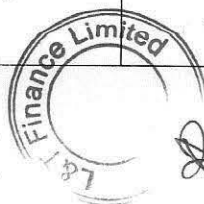

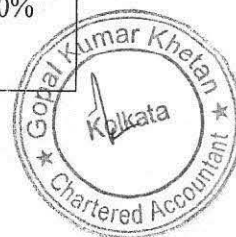
